6. Description of content: The Ministry of Environment & Forests, Govt. of India, vide this notification prescribes the standards for emission limits for new diesel engines (up to 800 kilowatt) for generator applications.
7. Objective and rationale, including the nature of urgent problems where applicable: Environment safety, pollution control. Rationale: Due to acute power shortage in the country, the generator sets have become the major source of energy in India. As a result of the use of generator sets in large numbers, pressure on the environment have become paramount. To control air pollution, the regulations have been put in place.
