**Subject: Voluntary disclosure of information relating to compassionate appointment by the concerned Ministries/Departments on their website –regarding.**

**Reference: DoP&T O.M No.41011/16/2019-Estt.(D) dated 20.05.2019.**

On the subject, the DOPT vide their OM cited above has directed all Ministries/Departments to take necessary action for suomoto disclosure of information on compassionate appointment. Accordingly, information about compassionate appointment made against the deceased employees of the erstwhile Directorate General of Supplies & Disposal (DGS&D) in May 2017 is as follows:-

- i. For considering the applications seeking compassionate appointment, a Screening Committee was constituted in the then Directorate General of Supplies & Disposal (DGS&D) Headquarters. A meeting of the Committee was held on 4.5.2017. After thorough examination of the 29 applications, the Screening Committee prepared a merit sheet for all the 29 applicants. The number of vacancies in the grade of MTS (erstwhile Group D) as on 01.05.2017 was 105. As per DoP&T's guidelines (vide OM No.14014/02/2012-Estt.(D) dated 16.01.2013), 5% of the vacant posts, which are required to be filled in through Direct Recruitment, can be reserved for appointment on compassionate grounds. Accordingly, the Committee decided to offer appointment as MTS to the following 5 applicants on the basis of merit score:-

- ii. After the Government of India took a decision on 12.04.2017 to wind up the DGS&D, all its offices have been closed with effect from 31.10.2017. The issue of compassionate appointment has been examined under the extant rules. It has been decided that no case of compassionate appointment in respect of employees/officials of erstwhile DGS&D and its regional offices could be processed in the Supply Division as the organization has already been closed. The same has been conveyed to all the applicants.
