A meeting of the Inter-Ministerial Committee (IMC) was held on 18-10-2016 in Udyog Bhavan, New Delhi under the Chairmanship of Shri A.K. Bhalla, Additional Secretary, Department of Commerce, for consideration of proposals for setting up of Inland Container Depots(ICDs)/Container Freight Stations(CFSs)/Air Freight Stations (AFSs) in India. From the developer's side no one attended the meeting to present the case for setting up an AFS at the proposed location.

The comments of all the four IMC members are as under: -

**Ministry of Railways** has given its **no objection** vide letter No.2014/TT-III/99/2, dated 16-03-2015.

**Ministry of Shipping,** vide letter No.PD-14033/23/15-PD-V, dated 20-01-2015, has given its **no objection** provided that container handling at their CFS and services to the stakeholders availing services related to container operations is not affected. The developer has to strictly follow the SOP formulated for CFS operations even after setting up of AFS vide letter dated 06-05-2015.

Ministry of Civil Aviation vide it's O.M. No.AV-16026/37/2015-ER, dated 07-09-2016 in their final comments reiterated it's earlier comments that the area for handling both export and import cargo by AFS is less than 2000 sq. mt. this has been confirmed in the site visit by AAI and requested to drop the proposal as the developer has also not furnished clarification on the lesser land area.

CBEC has given its comments in the IMC meeting vide O.M. letter No.434/03/2015-Cus-IV, where they have stated that the Policy guidelines issued by MoCA there is no provision for setting up of AFS at an existing CFS. There is only provision for setting up of Green field AFS facility or for AFS at an existing ICD. Department of Revenue has held a view that AFS can only come up at an existing ICD since AFS is an analogue of ICD on the air side, whereas CFS is just an adjunct to ICD. Accordingly, the aforesaid proposal is not approved by CBEC.

The proposal was considered in the IMC meeting with specific reference to the comments / observations of Ministry of Civil Aviation and CBEC and decided that the proposal be dropped and the developer duly take cognizance of the CBEC concerns while framing a proposal.

#### Agenda No. 07: (deferred proposal)

Setting up of rail linked ICD at Village Maranaiakanahalli, Taluk Anekal, Bengaluru, Karnataka by M/s Distribution Logistics Infrastructure Private Limited (formerly known as M/s Vikram Logistics and Maritime Services Pvt. Ltd (F. No. 16/14/2015-infra-l)

The developer mentioned that the proposal has been changed to a road based project from a rail-based project with area being reduced from 45 acres initially to 14 acres. It was informed by the developer that the trailers with containers would move on the connecting State and National Highways.

IMC was of the opinion that in view of the fact that the proposed road-based ICD is located near Bengaluru which is densely populated and a developed industrial zone there could be issues related to high volumes of traffic leading to congestion. In this perspective comments of the State Government are to be sought by Department of Commerce.

Comments of the members of the IMC on the revised proposal circulated on 08-09-2016 are awaited hence the proposal stands deferred.

No one from the developer's side has attended the meeting. IMC has further been apprised that no one attended the previous meeting also. Further, it has been noted that though the Letter of Intent (LoI) was issued in 2013, no substantive progress in infrastructure has been reported.

In view of the above, IMC decided that a show cause notice be issued to the developer asking him to explain as to why the LoI issued on 14-06-2013 cannot be cancelled / revoked as no substantial progress could be made so far.

#### Agenda No. 28

Extension of LOI for setting up of an ICD at Village Jattipur, Samalkha, Panipat, Haryana by M/s Continental Warehousing Corporation Ltd. (F.No.16/30/2013-Infra-I).

In a letter dated 01-09-2016, the developer sought extension for a period of 06 months i.e. upto 04-03-2017. Notifications 7, 8 and 45 have already been issued by the Customs. Location Code has also been issued on 11-04-2016. Developer is awaiting EDI connectivity going live.

IMC considered the above request and granted 3<sup>rd</sup>extension of LoI for a period of 06months beyond 04-09-2016 i.e. upto 03-03-2017

## Agenda No. 29

Extension of Lol for setting up of an ICD at Industrial complex Ranegreth, Kashmir by M/s J & K State Industrial Development Corporation Ltd. (F. No. 16/37/2005-Infra-1)

The developer in a letter dated 13-10-2016 has stated that the ICD has been completed in all respects. The issue of notifications has already been taken up with the Commissioner Customs, which is still awaited.

No one from the developer's side has attended the meeting. IMC decided to issue a notice to the developer as to why the project has not been made operational so far.

### Agenda No. 30:

As no request for extension of LoI has been received, he has been asked to send a specific request for extension of LoI alongwith the copy of the notifications, etc. However, IMC granted 2<sup>nd</sup>extension of LoI for 06 months beyond 29-10-2016 i.e. upto 29-04-2017.
