- (d) the other steps taken by the Government to help the tea garden workers, who lost their livelihood due to the closure of tea gardens; and
- (e) whether the Tea Board has been able to perform its regulatory role effectively and if so, the details thereof and if not, the reasons therefor along with the corrective measures taken by the Government in this regard?

REGARDING “CLOSED TEA GARDENS”**

(a) & (b): At present seven tea gardens in West Bengal and two tea gardens in Kerala are reported to be closed. The state wise details are given in annexure. The reasons for closure includes, inter alia, low yield from the estates, poor garden management practices, low quality produce, low price realizations and labour unrest etc.

(c) & (d): The condition of tea gardens is being monitored regularly by the Central Government through the Tea Board to facilitate reopening of the closed gardens. Government of India has requested the State Government to provide the benefits of social and economic development/welfare schemes of Central and State Government to all tea growing areas.

State Governments concerned have been taking several steps for revival of the closed gardens. The West Bengal Government has cancelled land lease in respect of Bundapani, Redbank, Dharanipur and Surendranagar tea estates and taken possession of the land to find out new entrepreneurs. Dheklapara estate was officially liquidated by the Hon'ble Calcutta High Court and the garden was put up for e-auction. However, no prospective buyer was available. Panighata Tea Estate has been recently closed due to labour unrest. Efforts are also being made by State Government of Kerala for reviving MMJ Plantations-Kottamala & Bonami Tea Estate and M/s Peermade Tea Co. Ltd.-Peermade & Lonetree Tea Estates.

(e): Tea Board is responsible for implementation of various regulatory and developmental functions under the Tea Act, 1953 for increasing production, marketing and export promotion. Tea Board has endeavoured to discharge its role effectively through implementation of the Tea Development and Promotion Scheme and enforcement of regulatory provisions.

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF LOK  
SABHA STARRED QUESTION NO. 70 FOR ANSWER ON 21<sup>st</sup> NOVEMBER, 2016  
REGARDING “IMPORT OF METALLIC SCRAP”**

- (a) to (d): As per the Foreign Trade Policy, 2015-20, import of 15 kinds of metallic scrap/wastes of any form is ‘free’ and is subject to the condition that it will not contain hazardous, toxic waste, radioactive contaminated waste/scrap containing radioactive material, any types of arms, ammunition, mines, shells, live or used cartridge or any other explosive material in any form either used or otherwise.

While shredded metallic waste and scraps are permitted through all ports of India subject to Pre Shipment Inspection Certificates (PSIC); import of unshredded metallic waste and scrap of these 15 metals were allowed only through the following 26 designated ports till 06/10/2016:

1. Chennai, 2. Cochin, 3. Ennore, 4. JNPT, 5. Kandla, 6. Mormugao, 7. Mumbai, 8. New Mangalore, 9. Paradip, 10. Tuticorin, 11. Vishakhapatnam, 12. Mundra, 13. Kolkata, 14. Pipava, 15. ICD Loni, Ghaziabad, 16. ICD Ludhiana, 17. ICD Dadri (Greater Noida), 18. ICD Nagpur, 19. ICD Jodhpur, 20. ICD Jaipur, 21. ICD Udaipur, 22. CFS Mulund, 23. ICD Kanpur, 24. ICD Ahmedabad, 25. ICD Pitampur and 26. ICD Malanpur.

This policy was reviewed by the Government keeping in view the increasing demand for import of unshredded scrap through other ports, besides the above 26 designated ports. On the basis of inter-ministerial consultations, it was considered necessary to check the contaminated consignments at the port of entry and not to allow these to the hinterlands. Accordingly, the above entry points were revised for unshredded metallic waste/scraps vide the Public Notice No.38/(2015-2020) dated 06/10/2016.

As per this Public Notice, any sea port to be designated for import of un-shredded metallic scrap will be required to install Radiation Portal Monitors and Container Scanner with adequate security. The sea port having completed the above shall approach jurisdictional Customs for inspection and certification. Customs may give necessary clearance on receipt of certification from Atomic Energy Regulatory Board (AERB). On getting clearance from Customs, DGFT will notify such a port as designated port for import of un-shredded scrap.

The existing designated 14 sea ports namely Chennai, Cochin, Ennore, JNPT, Kandla, Mormugao, Mumbai, New Mangalore, Paradip, Tuticorin, Vishakhapatnam, Pipava, Mundra and Kolkata will be allowed to import un-shredded scrap till 31<sup>st</sup> March, 2017 by which time they are required to install and operationalize Radiation Portal Monitors and Container Scanner. Such sea ports which fail to meet the deadline will be derecognised for the purpose of import of un-shredded metallic scrap w.e.f 1.4.2017.

Further, any ICD can handle clearance of un-shredded metallic scrap provided the same passes through any of the designated sea ports as mentioned above or any new ports to be notified/designated from time to time, where Radiation Portal Monitors and Container Scanner are in operation and the consignment is subjected to risk based scanning/ monitoring as per the protocol laid down by Customs.

Notwithstanding the above, import consignments shall be subject to pre-inspection certificate from the country of origin.

- (b) and (c): The Government continues to engage proactively with SAARC countries, including Nepal, to strengthen trade and economic relations. Issues impacting bilateral trade, raised by these countries, are taken up for an early

resolution. Bilateral and multilateral trade discussions are held with these countries from time to time to explore mechanisms for enhancement of cross border trade.

Issues relating to improvement of trade infrastructure in the form of upgradation of Land Customs Stations are also coordinated.

Further, assistance is provided under Market Access Initiative(MAI) and Market Development Assistance(MDA) schemes to Indian exporters, Export Promotion Councils, Apex Trade Bodies etc. for participation in events in foreign countries, including Nepal.

d) The share of India's exports to the SAARC countries vis-a-vis India's total exports has increased from 5.57% in 2013-14 to 6.42% in 2016-17 (April-August) and the share of India's imports from the SAARC countries vis-a-vis India's total imports has increased from 0.55% in 2013-14 to 0.73% in 2016-17 (April-August), thereby strengthening India's gains from trade.

**IMPORT OF WASTE MATERIAL**

- (a) whether there is an import of waste, garbage and scrap material from other countries, particularly the western countries into India and if so, the total amount of waste, garbage and scrap imported into the country in the last five years;
- (b) whether all of these imports are reused locally for local requirements and to fuel small industries and if so, the details thereof;
- (c) whether any of these imports are harmful health-wise to the people and if so, the steps being taken by the Government to prevent or reduce these harmful effects;
- (d) whether these imports are governed by any legislation/rules framed by the Government; and
- (e) if so, whether all imports are being done in accordance with these rules/laws and if so, the details thereof?

- (a) Details of various kinds of wastes and scrap imported into India in the last five years is annexed.
- (b) Recycled Metal scrap is a secondary raw material which converts wastes /scraps into new raw materials. The recycling process promotes small industries which use recycled scraps from sectors like automotive, power, infrastructure, construction and white goods. Recycling is environmentally more sustainable and it is a cheaper source of raw materials.
- (c) to (e): Import of any form of metallic waste, scrap is subject to Pre-Shipment Inspection Certificate (PSIC) from the Pre- Shipment Inspection Agencies (PSIA) for radiation & arms and ammunition. Any violation in terms of import conditions or wrong certification is penalized under the provisions of the Foreign Trade (Development and Regulation) Act, 1992 (as amended from time to time).



Further, Department of Electronics & Information Technology (DeitY) is involved in developing technology to recycle e-waste in an environment friendly manner. Under DeitY, a number of R&D projects have been initiated to find out technological solution on e-waste recycling in environment friendly manner.

Moreover, under the Environment Protection Act, 1986 and Rules framed thereunder, import of products, equipment containing Ozone Depleting Substances (ODS) is subject to Rule 10 of the Ozone Depleting Substances Rules, 2000. Similarly, the Government has comprehensively revised its regulation on hazardous materials through Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016 dated 4<sup>th</sup> April, 2016 wherein items included in the Schedule-VI of the Rules are prohibited for import from all countries. Import of Hazardous Chemicals is also subject to the provisions of the Manufacture, Storage and Import of Hazardous Chemicals Rules, 1989 (made under the Environment (Protection) Act, 1986) and violations of provision under these acts / rules are punishable as per the provisions under these Acts / Rules.

- (b) Encouraging exports of agricultural products (including maize) is a continuous process. The Agricultural and Processed Food Export Development Authority (APEDA), an autonomous organisation under the Department of Commerce, provides financial assistance to the exporters through various components of its Plan Scheme viz. Infrastructure Development, Market Promotion, Quality Development and Transport Assistance. Besides these measures, the Ministry of Commerce & Industry has put in place various schemes namely Market Development Assistance (MDA), Market Assistance Initiative (MAI) etc. to provide assistance to encourage exports.

The export of agricultural products depends on various factors including availability of surplus over and above the requirement of buffer stock including strategic reserve, if any, concerns of food security, diplomatic/humanitarian considerations, international demand and supply situation, quality standards in the importing countries, varieties traded and price competitiveness. Export of maize has fallen during the past

two years due to a variety of factors such as supply side constraints due to poor crops, high domestic prices which have made exports uncompetitive, etc.

Directorate General of Anti-Dumping & Allied Duties (DGAD) initiated an anti-dumping investigations on imports of “Seamless tubes, pipes & hollow profiles of iron, alloy or non-alloy steel (other than cast iron and stainless steel), whether hot finished or cold drawn or cold rolled of an external diameter not exceeding 355.6 mm or 14” OD”, originating in or exported from China PR, on 8.7.2015, on the basis of a duly substantiated petition filed by the domestic industry with a prima-facie evidence of dumping of said goods into the country causing injury to the domestic industry.

DGAD vide its notification dated 31.3.2016 recommended to Department of Revenue, for imposition of provisional anti-dumping duty on imports of aforesaid products imported from China PR to offset dumping and injury, pending completion of this investigation. Department of Revenue, vide its notification No. 18/2016-Customs(ADD) dated 17<sup>th</sup> May,

2016 has imposed provisional anti-dumping duty in the range of US\$ 961.33 to 1610.67 per

- (a) & (b): Government e-Marketplace (GeM) is a new initiative of Government launched in August 2016. GeM is expected to bring more transparency and efficiency in public procurement as it is a completely online and end-to-end procurement portal with simplified and automated processes for vendor and buyer registration, product/service listing, contract placement & management and time-bound payment to vendors. Since it is a marketplace, it provides a platform for dynamic pricing along with tools for Bidding & Reverse Auction as against static & long term pricing on NICS and DGS&D Rate Contract. The rates on GeM are found to be more competitive in comparison between the rate listed under GeM, NICS and Rate Contract has been done in few select Goods and Services in the following table and it could be seen that the rates offered in GeM based on actual order are lesser than NICS and Rate Contract. Further, rates offered in GeM are dynamic in nature.

The current prices on e-commerce sites are made available on GeM portal for the benefit of the buyers to establish price reasonableness. However, precise comparison cannot be done on account of different terms & conditions on GeM and e-Commerce sites. It has been invariable noticed that when buyers have gone for Bidding or Reverse Auction, the prices obtained are much lower than the e-Commerce sites. Buyers are encouraged to go in for Bidding/RA in order to derive maximum benefits.

(c): Jharkhand High Court procured 699 numbers of Intel i3 based Desktop Computers Model No.RC-31-Dell Optiplex 3040 MT and 233 numbers of Intel i5 based Desktop Computers Model No. RC-35-Dell Optiplex 3040 MT through GeM. Jharkhand High Court had taken prior approval of the competent authority for purchasing these specific models of Dell make Desktop computers through GeM.

(d): The Desktop Computers purchased by Jharkhand High Court were not available on DGS&D Rate Contract. The Desktop computers available on GeM and purchased by Jharkhand High Court were of superior 6<sup>th</sup> Generation processor as against 4<sup>th</sup> generation processor of Dell make available on DGS&D RC. Nevertheless, the GeM prices for the purchased computers were same as that of the 4<sup>th</sup> Generation computers on DGS&D RC.

- (a) & (b) : Yes Madam, the negotiations on fisheries subsidies resumed in 2015 before the Nairobi Ministerial meeting. In the World Trade Organisation (WTO) negotiations on fisheries subsidies, India has been seeking effective special & differential treatment for developing countries.
- (c) & (d) : Proposals for finding a permanent solution on public stockholding for food security purposes and an agricultural special safeguard mechanism for developing countries are ongoing negotiations in the WTO. India is working with the WTO members, especially the G-33 group of developing countries which is instrumental in advancing negotiations on these agricultural issues. Apart from the meetings in the WTO, India has been emphasizing the need for implementation of the Bali and

Nairobi Ministerial Decisions on these issues on priority, in other meetings. In a recent informal gathering of Trade Ministers convened by Norway in Oslo on 21-22 October 2016, India underscored the need for prioritizing work on the Ministerial Decisions of special interest for developing countries.

- (e) : In the WTO Committee meetings held recently, some of the member countries have raised questions about India's safeguard investigations concerning certain aluminium and steel products, India has been defending its interests by appropriate interventions justifying its action under the WTO safeguard mechanism.

- (a) and (b): The Government has comprehensively revised its regulation on hazardous materials through Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016 dated 4<sup>th</sup> April, 2016 wherein plastic waste has been included in the Schedule-VI of the above Rules and the item is prohibited for import from all countries since then.
- (c) The Foreign Trade Policy (2015-2020) provides safeguards against poor quality imports by providing for Domestic Laws/ Rules/ Orders/ Regulations / Technical Specifications/ Environmental/ Safety and Health Standards applicable to domestically produced goods to be applicable, mutatis mutandis, to imports, unless specifically exempted. Wherever, there are domestic standards for goods, those standards are also applicable to imported goods.

India has an elaborate and robust legal framework and institutional set up to protect its environment, life and health of its people, plants and animals. Apart from the Hazardous Rules as stated in the part (a) & (b) above, the BIS standards, applicable to domestic goods, are also applicable to imported goods. For imported food and edible items, Food Safety and Standards Act (FSSA), 2006 and Rules there under are also applicable.

The Standards Committee on Plastics has been formed comprising Ministry of Chemicals and Petrochemicals, Plexconcil, PlastIndia, Central Institute of Plastics Engineering and Technology and other bodies representing plastic producers in formulating / developing a mechanism to thwart the import of substandard low quality, toxic and hazardous plastics entering the Country.

Indigenous industries can also seek protection under various trade defense measures like anti – dumping duty, countervailing duty and safeguard duty.

The “Agriculture Export Promotion Plan Scheme of APEDA” is a Central Sector Plan Scheme, which was approved by the Cabinet Committee on Economic Affairs on 25<sup>th</sup> November 2013, with an outlay of Rs.1100 crores for the 12<sup>th</sup> Plan (2012-13 to 2016-17). The Components of the Plan Scheme are as under:

- 1) Infrastructure Development: APEDA provides financial assistance to the exporters and export related government/ cooperative institutions for setting up of infrastructure such as Centres for Perishable Cargo at International airports and seaports and pack house facilities with packing/grading lines, pre-cooling units with cold storages and refrigerated transportation etc.
- 2) Transport Assistance: In order to mitigate the disadvantage of high air freight and sea freight rates, APEDA provides transport assistance on selected fruits,

vegetables, flowers, poultry, dairy and other processed food products etc. for exports both by sea and air.

- 3) **Quality Development:** Financial assistance is provided for the implementation of food safety management systems like HACCP, BRC, GAP and ISO-9001 etc. to enhance the export capability and credibility of Indian agro products.
  - 4) **Market Development:** Financing of Market Intelligence setup, participation in International Fairs & Exhibitions, exchange of trade delegations and assistance for packaging development is done under the component.
- (b) The details of the funds earmarked, allocated and utilised under various components of the Plan Scheme, during the 12<sup>th</sup> Plan period (2012-13 to 2016-17), are at **Annexure-I**.
- (c) The details of India's exports of fruit/vegetables, during the last three years and the current year, are at **Annexure-II**.
- (d) The details of financial targets fixed and achievements made against these targets are at **Annexure-I**
- (e & f) APEDA was able to completely utilise the allocations made during the years 2012-13 to 2014-15. However, during the year 2015-16, APEDA was not able to utilize the allocation of Rs.5 crore under the Special Component for Scheduled Castes, which was surrendered. As financial assistance under the Plan Scheme is provided to exporters, which are mostly incorporated entities, or Government agencies and not to individuals, APEDA was not able to identify suitable beneficiaries for the Special Component for Scheduled Castes.

(a): Spices Board is mandated for development, research and marketing of small and large cardamom and post harvesting improvement of spices having export potential. The Board is also responsible for the export promotion of Spices.

(b)&(c): Spice Board is implementing the "Export Oriented Production, Export Development & Promotion of Spices" Scheme wherein, assistance is provided to cultivators of small and large cardamom the form of subsidies through various programmes for production of quality planting materials, replanting of old and uneconomic gardens, new planting, irrigation development programme, improved curing facilities, farm mechanization, etc. for boosting production. Apart from the above, Spices Board implements several programmes for spices cultivators which inter alia includes development of infrastructure for common processing facilities in Spice Parks, adaptation of upgraded technology in spice processing, setting up of quality evaluation labs, quality certification and training of laboratory personnel, assistance to farmers on post-harvest quality improvement and imparting training to farmers in Good Agricultural Practices etc.

(d)&(e): The major challenges faced by the spice industry are price fluctuations, quality issues at farm level and low productivity due to climate vagaries, incidence of pests & diseases etc. In order to address the issue of price fluctuation, the Ministry has recently approved Revenue Insurance scheme for Plantation Crops, which includes small and large cardamom, to be implemented on pilot basis for protecting the farmers against losses arising from

both fluctuations in yield as well as prices. Through the 12<sup>th</sup> Plan Scheme, various programmes for increasing the production and quality of small and large cardamom are effectively undertaken.

If perforce a portion of double cropped agricultural land has to be acquired to meet the minimum area requirements, especially for multi-product SEZs, the same should not exceed 10% of the total land required for the SEZ. The Board of Approval for SEZs (Central Government) only considers those proposals, which have been duly recommended by the State Government.

(a) to (c): Cold Form Foil (Mfrs.) Association had submitted a representation dated 17<sup>th</sup> March 2015 requesting withdrawal of exemption granted to the import of Cold Form Foil (final product) from South Korea under India-Korea CEPA.

Aluminium Association of India vide their letter dated 22<sup>nd</sup> May 2015 supported the request of Cold Form Foil (Mfrs.) Association. A request regarding withdrawal of custom duty exemption granted to South Korea on Alu-Alu Foils (Cold Form Foils) under India-Korea CEPA was also received from Hon'ble Member of Parliament, Shri Kaushalendra Kumar in August 2016.

The issue was examined by the Government. Under the India-Korea CEPA agreement which entered into force w.e.f. 01.01.2010, the customs tariffs on Aluminium foils (under HS 7607) were committed for progressive elimination. The Indian schedule of tariff concessions under CEPA had been finalised in 2009 after extensive stakeholder consultations with the domestic industries and the line Ministries/Departments. As was also informed to Hon'ble MP, Shri Kaushalendra Kumar vide letter dated 7<sup>th</sup> October 2016, it is not presently feasible to unilaterally withdraw the tariff concessions as the India-Korea CEPA is an international bilateral trade agreement under which both the countries have taken on certain commitments. However, the agreement incorporates safeguard provisions which can be invoked, on a case by case basis, in case of serious injury or threat thereof to the domestic industry from the other party is established.

(d) to (e) No compilation of production and sales data of Alu-Alu foils is presently available to substantiate that no one was producing Alu-Alu foils in India in 2010. Moreover, as per the details provided by DGCI&S, the share of Korea in the total imports of Aluminium foils under HS code 76072090 has been hovering at 16 to 21 % during the last three years. In the last year i.e. 2015-16, it was 16.49% of the total import.

- (c) The above data reveals that there is a small increase in the trade gap during the period 2014-15 over 2013-14. However, the trade gap has decreased in 2015-16 and the current year compared to corresponding period of previous year.

- (d) The Government has taken following measures to improve the trade deficit with other countries:

- (i) The New **Foreign Trade Policy (2015-20)** was announced on 1<sup>st</sup> April, 2015 with a focus on supporting both manufacturing and services exports.
- (ii) The Merchandise Exports from India Scheme (MEIS) was introduced in the Foreign Trade Policy (FTP) 2015-20 on April 1, 2015. The Government has extended the market coverage to all countries in respect of 7914 lines. The revenue forgone under the scheme (MEIS) has increased from Rs. 22000 Crore to Rs. 23500 Crore per annum.
- (iii) The Government launched Services Exports from India Scheme (SEIS) in the FTP 2015-2020. The Scheme provided rewards to service providers of notified services who are providing service from India.
- (iv) The Government is implementing the **Niryat Bandhu** Scheme with an objective to reach out to the new and potential exporters including exporters from Micro, Small & Medium Enterprises (MSMEs) and mentor them through orientation programmes, counselling sessions, individual facilitation, etc., on various aspects of foreign trade for being able to get into international trade and boost exports from India.
- (v) By way of trade facilitation and enhancing the ease of doing business, Government reduced the number of mandatory documents required for exports and imports to three each, which is comparable with international benchmarks. The trade community can file applications online for various trade related schemes. Online

payment of application fees through Credit/Debit cards and electronic funds transfer from 53 Banks has been put in place.

(vi) Interest Equalization Scheme on pre & post shipment credit launched to provide cheaper credit to exporters.

(vii) Further, the Government continues to provide the facility of access to duty free raw materials and capital goods for exports through schemes like Advance Authorization, Duty Free Import Authorization (DFIA), Export Promotion Capital Goods (EPCG) and drawback / refund of duties.

(e) Efforts are continuously made through missions abroad to increase overall exports by diversifying the trade basket with emphasis on manufactured goods, services, resolution of market access issues and other non-tariff barriers.

(a) & (b): The tariff concessions being granted to Asia Pacific Trade Agreement (APTA) member States, on Margin of Preference basis, under the fourth round of exchange of tariff concessions, includes certain tariff lines relating to railway locomotives, nuclear plants, fissile material and aircraft. The Union Cabinet, in its meeting on 12th September, 2016 has approved the exchange of these tariff concessions. The decisions of the Cabinet would be implemented at the next meeting of the Ministerial Council of APTA.

The APTA (formerly the Bangkok Agreement) is an Agreement signed since 1975. Three Rounds of tariff concessions have already been exchanged among the member countries till 2003. The current membership of APTA consists of six countries, namely, Bangladesh, China, India, Lao PDR, Republic of Korea, and Sri Lanka.

(c) & (d): India is part of the Regional Comprehensive Economic Partnership (RCEP) which is a proposed Free Trade Agreement (FTA) amongst sixteen countries consisting of ten ASEAN member states and their six Free Trade Partners namely India, Australia, China, Japan, New Zealand and Republic of Korea. The RCEP is intended to facilitate and thereby increase goods and services trade as well as investment flows amongst the participating countries. India has stressed on the need for parallelism between the negotiations on goods and services. The negotiations of the Trans-Pacific Partnership (TPP) have been concluded but the agreement is not yet ratified for implementation by the participating countries. India is not part of the Trans-Pacific Partnership Agreement.

(e) : In order to protect the interest of the local manufacturing (domestic industry), the FTAs provide for maintaining sensitive/negative lists of items on which limited or no tariff concessions are granted under the agreement. In addition, in case of a surge in imports and injury to the domestic industry, a country is allowed to take recourse to the measures such as anti-dumping and safeguards.

As per the latest “Quarterly report on changes in employment in selected sectors” released by Ministry of Labour and Employment, employment in the exporting units has increased by 31 thousand at overall level during the period ending September, 2015 over June, 2015.

- (a) The 1<sup>st</sup> BRICS Trade Fair was organized at Pragati Maidan in New Delhi from 12-14 October 2016.
- (b) to (d): The BRICS Trade Fair was completely an interactive business engagement and was organized with an objective to promote trade and investment opportunities amongst the participating BRICS nations i.e. Brazil,

Russia, India, China and South Africa. 397 companies participated at the BRICS Trade Fair to showcase the capability of each of the BRICS nations in the identified sectors. About 910 companies participated at various BRICS business engagements and nearly 1601 Business-to-Business (B2B) Meetings took place over three days. The BRICS Trade Fairs, like the other business to business International Trade Fairs was a unique platform for showcasing technologies, goods and services, exploring opportunities for businesses and entering into dialogues and discussions for joint venture partnerships and collaborations. As the BRICS Trade Fair was not a direct consumer fair allowing sales of merchandise, the immediate revenue earned by participating Indian Companies cannot be quantified.

- (e) India organised the 1<sup>st</sup> BRICS Trade Fair during its Presidency pursuant to the announcement made by Hon'ble Prime Minister of India during the BRICS Summit at Ufa, in 2015. The Presidency of BRICS will move to China in 2017 and they would need to take a decision on the organisation of the next BRICS Trade Fair.
