(a) Yes, Sir.

(b) and (c) : Detailed recommendations of the HLAG are available on the website of the Department of Commerce (<https://commerce.gov.in>).

(d) The suggestions and recommendations of the report of the HLAG have been shared with the different departments concerned.

(e) As regards reforms in tax system, it is stated that through Taxation Laws (Amendment) Ordinance, 2019 (the Ordinance), corporate tax rates have been reduced to 22% plus applicable surcharge and cess for all domestic corporate persons not claiming any deduction or incentive. Further, an option has been given to any new domestic manufacturing companies incorporated on or after 01.10.2019 to avail lower corporate tax rates of 15% with applicable surcharge and cess without claiming any deduction or incentive as per sub-section (2) of the section 115BAB of the Act, provided they commence manufacturing or production of an article or thing by 31.03.2023. Government has already carried out a number of reforms in various sectors and the reform process is a continuous process for the improvement in the economy. Some of these are by way of amendments in various acts such as the Finance (amendment) Bills, The Special Economic Zones (Amendment) Bill, Amendments in the Goods and Services Tax Act, the Insolvency and Bankruptcy Code, etc.

(a): There are several Government schemes to incentivise and facilitate exports of goods from India, which are largely available to the costume & fashion jewellery sector also. These include various export promotion schemes and Duty Drawback Scheme.

(b), (c) and (d): Clusters for various products have developed at different locations across the country facilitated by infrastructure and other facilities, inter-alia, provided under different Government programmes. These include clusters related to jewellery / costume and fashion jewellery. These are supported through various Government programmes like development of Common Facility Centres (CFCs) in Gems and Jewellery Manufacturing Clusters, through which the Government will continue to support such activities.

- (a) whether the Government has failed to comply with the eligibility criteria for the Preferential Trade Status (PTS) under the Generated System of Preferences (GSP) programme of the US Government and if so, the details thereof;
- (b) whether the Government has failed to convince the US Government on India's compliance with the eligibility criteria for the PTS, if so, the details thereof and if not, the reasons therefor;
- (c) the details of the grounds cited by the US Government for the termination of special trade status;
- (d) whether the Government was aware of the eligibility review launched by the US Government in April, 2018;
- (e) if so, the details of the steps taken by the Government to convince the US Government on the measures taken by India to fulfill the criteria since April, 2018;
- (f) whether this will impact the volume of exports to the US and if so, the details thereof along with the potential job loss and other economic effects caused due to the cancellation of PTS; and
- (g) the details of the steps taken/to be taken by the Government to counter those effects?

- (a) to (e)** The Generalised System of Preferences (GSP) is a unilateral scheme given by developed countries like the United States under the legal decision of 28.11.1979 named as "*Differential and More Favourable Treatment Reciprocity and Fuller Participation of Developing Countries*" also known as the "*Enabling Clause*" agreed upon by the GATT Contracting Parties and subsequently incorporated into the WTO legal system.

Under the United States GSP program, certain products can enter the United States duty-free if beneficiary developing countries meet the eligibility criteria established by their Congress. GSP criteria include, among others, respecting arbitral awards in favour of United States citizens or corporations, combating child labour, respecting internationally recognized worker rights, providing adequate and effective intellectual property protection, and providing the United States with equitable and reasonable market access. Countries can also be graduated from the GSP program depending on factors related to their economic development.

The United States launched an eligibility review of India's compliance with the GSP market access criterion in April 2018. The petitions filed by the U.S. dairy industry and the U.S. medical devices industry were also included in this review, which alleged that Indian trade barriers affected U.S. exports in these sectors. India had submitted Pre-Hearing Briefs, attended the Public Hearing and also submitted Post-Hearing Briefs, to USTR (U.S. Trade Representative) in June, 2018.

During the process of GSP review, USTR added various demands including greater market access for a number of its products and used the non-reciprocal GSP benefit as a lever to extract further concessions from India. Though India took its best efforts to arrive at a mutually beneficial trade package, the US review culminated in issuance of withdrawal notice by the US on 4th March, 2019 and GSP benefits was withdrawn with effect from 5th June 2019.

The US indicated that it withdrew the GSP for India under Section 502 of its Trade Act of 1974 citing that India did not provide equitable and reasonable access to its markets in numerous sectors.

(f) and **(g)** In 2018, India exported goods worth of \$ 6.3 billion (as per USTR figures) to U.S. under the GSP programme, which was approx 12.1% of India's total export to U.S. The average duty concessions accruing on account of GSP were approx. \$ 240 million in 2018, which was about 3.8% of India's exports to the U.S. availing the GSP benefits. The impact varies across products, depending on the individual product level concessions which were availed under the GSP. However, so far the cumulative exports under the GSP tariff lines have not declined in the post GSP withdrawal period (June – Oct 2019) as compared to the corresponding period of the previous year.

Bilateral trade discussions are a part of any economic engagement and such issues also form a part of the discussions in India's ongoing economic engagement with the US.

- (a) whether Khammam district has more than 500 granite slab industries and 200 granite tile industries and if so, the details thereof;
- (b) the steps being taken for exports of such granite by setting up of Railway Siding near Pandillapalli railway station in Khammam district to generate more revenue; and
- (c) if so, the details thereof and the steps being taken by the Government in this regard?

- (a) Department of Commerce has set up Export Promotion Councils for promoting exports of various product groups / sectors. The mandate of export promotion of Natural Stones, including Granite has been assigned to Chemicals & Allied Products Export Promotion Council (CAPEXIL), headquartered at Kolkata. The Council has informed that the Khammam Granite Association has reported 469 Granite Slab factories located in the District and the Granite Tile Association, Khammam has 114 Granite Tile Industries. The Details of the Granite Slab factories and the Granite Tile Industries may be seen at **ANNEXURE - I**.
- (b) and (c) It is informed that Pandilapalli Railway Station is not open for goods traffic and is presently dealing with only passenger traffic. The nearest goods shed is Khammam which is about 9 Kms from Pandillapalli station. A siding can be provided only on deposit terms at Pandillapalli station for loading Granite.

- (b) whether the Government has identified districts possessing respective potential for fisheries and dairy products and developing them as clusters for its exports, if so, the details thereof and the achievements made in this regard;
- (c) whether other developing and developed countries have evinced interest in investing in India's agriculture sector, especially fisheries and dairy products;
- (d) if so, the details thereof along with the extent to which it will be helpful to fetch good price for fisheries and dairy products;
- (e) the details of the status of the implementation of Agricultural Export Policy, 2018;
- (f) whether the Government has assessed the impact of the policy on the States and if so, the details thereof; and
- (g) the details of the other measures taken by the Government to increase the income of farmers and the success achieved in this regard so far?

ANSWER

THE MINISTER OF COMMERCE AND INDUSTRY
(SHRI PIYUSH GOYAL)

(a) Yes Sir. In the year 2018-19, India exported marine products worth US\$ 6.8 billion (1.39 million tons) and the total fish production in the country was approximately 13.34 Million Tons with an increase of about 6% over the previous year's production (12.59 Million Tons in 2017-18) and

1.1% in export quantity (1.37 million tons). Hence, there is a potential for the export of fishery products from India.

With regard to the dairy sector, India ranked first in milk production with 176.35 Million Metric Tons in FY 2017-18. During 2018-19, India's export of milk and milk products was Rs. 2423 Crore which is about 1% of World export. Hence, there is a potential for growth in Indian dairy products export also.

(b). The Marine Products Export Development Authority (MPEDA) promotes cluster farming of aquaculture in all the maritime states and has formed 918 aquaculture farming societies involving 19,854 farmers. The district wise details of such societies is attached as **Annexure-I**. Through these societies, MPEDA provides technical and financial assistance to promote sustainable aquaculture and increase the aquaculture production. The farmers of these societies are encouraged to follow Better Management Practices (BMPs) for ensuring disease free production.

With regard to the promotion of dairy products exports, Mathura District in Uttar Pradesh and Banaskantha District in Gujarat have been identified as clusters for dairy products.

(c) & (d) Some countries have shown interest in investing in the Agriculture sector of India. The foreign investment in the Agriculture services sector in last 3 years i.e. from April 2016 till June, 2019 has been about US\$ 283.5 million. Out of this, investment in fisheries sector is US\$ 3.8 million and in the dairy sector is US\$1.94 million *(as per the data available with DPIIT)*.

(e) & (f) The steps taken to implement the Agriculture Export Policy are annexed at **Annexure – II**. Since the Policy was announced in December 2018 and it is in the initial stage of implementation, no impact assessment of policy on the states has been done so far.

(g) With regard to the Fisheries Sector, the Government through Marine Products Export Development Authority (MPEDA) has undertaken certain proactive measures whose details have been mentioned at **Annexure-III**. With regard to the Dairy Sector, the Department of Animal Husbandry & Dairying has been implementing the following Dairy Development Schemes which aim at benefitting the farmers through creation of dairy processing and marketing infrastructure across the country:

- i. National Programme for Dairy Development (NPDD)
- ii. National Dairy Plan-I (NDP-I)
- iii. Dairy Entrepreneurship Development Scheme (DEDS)
- iv. Dairy Processing and Infrastructure Development Fund Scheme (DIDF)

These schemes support State Governments and State Dairy Federations/ Milk Unions to enhance their capacity in terms of dairying in respective States.

- i. An Inter-Ministerial Committee (IMC) has been formed to monitor the implementation of AEP.
- ii. The mandate of the existing CoS on Review of prices of essential Commodities has been expanded to identify the agricultural commodities essential for food security, only which will be subject to export restrictions if the need arises.
- iii. Workshops on promoting awareness of Agri Export Policy have been organized.
- iv. The Agricultural and Processed Food Products Export Development Authority (APEDA) has prepared State-specific Action Plans and shared them with the respective states for vetting and finalization. A number of States, including Maharashtra, have vetted and finalized their respective plans. The matter is being pursued with the remaining states/UTs.
- v. 27 States and 2 UTs have designated nodal agencies to promote agriculture exports.
- vi. APEDA and National Cooperative Development Corporation (NCDC) have signed an MoU for greater involvement of cooperatives in agriculture exports.
- vii. BSM between State authorities, Cooperatives, exporters are being held along with NCDC in all the States & UTs in a phase wise manner during October to December, 2019.
- viii. A Farmer Connect Portal has been set up by APEDA on its website for providing a platform for FPOs, Cooperatives to interact with exporters.
- ix. Under the AEP, a number of clusters have been identified for export-oriented products of specific products. APEDA is organizing Buyer-Seller Meets (BSMs) between exporters and Farmer-Producer Organizations (FPOs) at cluster level in every state.
- x. A new Central Sector Scheme – Implementation of Agriculture Export Policy – has been approved with an outlay of Rs. 206.80 crores for 2019-20.

Annexure-III

MPEDA provides financial assistance to encourage aqua farmers to adopt Better Manufacturing Practices in Aquaculture. The farmers are eligible for assistance @50% of capital cost or a maximum of 5 lakh. For SC/ST beneficiaries the quantum of assistance will be 75% of capital cost or maximum of 7.5 lakh. The assistance includes installation of bio-security infrastructures.

MPEDA is also providing capacity building & skill development assistance to Aqua farmers by rendering Training, Awareness Campaigns, Farmers meet, Workshops etc. MPEDA also encourages cluster farming by formation of Aqua farmers Welfare Societies through its Society called the National Center for Sustainable Aquaculture (NaCSA).

The unit offices of MPEDA established across maritime States in the country are providing aquaculture development services to the aqua farmers in the country. Demonstration farm projects are run by these unit offices involving farmers. 11 ELISA Labs established near farming areas for providing service to the farmers for testing their produce for detection of antibiotics.

Rajiv Gandhi Center for Aquaculture (RGCA), the Research and Development wing of MPEDA has established 11 projects for diversifying export oriented aquaculture. These projects are facilitating aquaculture by sale of seeds and providing technical assistance.

The above initiatives of MPEDA are aimed at increasing the production of aquaculture and export of marine products.

(a): As per Schedule – 2 of Indian Trade Clarification (Harmonised System) Export Policy, 2018, all commodities / items have been categorized into three categories namely (i) free (ii) prohibited; and (iii) restricted. Barring a few items, all items are free for export. However, 'Free' exportability is subject to any other law for time being in force. While 'Prohibited' items are not allowed for export, items which fall under 'restricted' category are permitted for export subject to export authorization issued by Directorate General of Foreign Trade.

(b): Export could be made to any country, except as restricted under the Foreign Trade Policy 2015-20, as per international obligations/United Nations Security Council embargo.

(c) (d) and (e): India has signed Free Trade Agreements (FTA) with a number of trading partners, including small countries. These agreements provide opportunities for exports to these trading partners at preferential duties. The annual exports to the FTA partners, including small countries, over the last 3 years, are given in the Annexure.

(a) & (b): Yes, Sir. Under Agriculture Export Policy, 2018, Poultry Clusters at Namakkal, Salem and Erode districts of Tamil Nadu State have been identified for increasing supply and exports of poultry products.

(c): At present, there is no plan to set up such cluster in the State of Telangana.

(d): The concept of separate export zones was introduced by the Government through Exim Policy in 2001. Due to non-satisfactory performance of the Agri Export Zones (AEZ), the Ministry constituted a Peer Review Group for its re-valuation. On the basis of the recommendations of the Peer Review Group, it was decided not to consider and approve new separate AEZ. The constraints like lack of interest and coordination amongst the stakeholders, lack of separate allocation of funds by the State Governments, lack of project orientation and conceptual design of separate AEZ etc. were noticed. However, Department of Animal Husbandry and Dairying has recognised 29 poultry establishments (i.e. 10 establishments in Tamil Nadu, 13 establishments in Maharashtra and 6 establishments in Chhattisgarh) as 'Compartment free from Avian Influenza' as per norms of World Organisation for Animal Health (OIE) intended for export of poultry and poultry products.

(C): Yes, Sir. The purchases through GeM by Ministries and Government Departments have been made mandatory by Ministry of Finance through Rule No.149 in the General Financial Rules,2017. In case of CPSEs, government has issued directions to use GeM for all their procurement.

(d): Yes, Sir. The transparency, efficiency and inclusiveness provided by the GeM portal has resulted in an average saving of around 15-25% (excluding automobiles where it is 12%) to the Government exchequer.

- (a) A product is allowed to be exported as “Organic Product” only when accompanied by a Transaction Certificate issued by a Certification Body accredited by National Accreditation Body (NAB) for organic products under the National Programme for Organic Production (NPOP) of the Department of Commerce. ‘Organic Products’ for export will be so certified only if produced, processed and packed as per the standards laid down in NPOP.
- (b) Region-wise data is not maintained. The State/UT-wise details of the organic agri-products exported from the country during 2018-19 are at Annexure-I.
- (c) The promotion of exports of organic products is a continuous process. The Agriculture Export Policy provides that no restrictions will be placed on export of organic products. The Agricultural & Processed Food Products Export Development Authority (APEDA), an autonomous organisation under the administrative control of Department of Commerce, has been mandated with the export promotion of organic products. APEDA provides assistance to the exporters of organic products under various components of its export promotion scheme. APEDA also undertakes various activities to promote exports of organic products viz. addition of new products under NPOP, making efforts to get NPOP standards recognized by the importing

countries, promoting 'India Organic' brand through participation in international trade fairs and exhibitions, organising Buyer-Seller Meets (BSMs), organising capacity building and outreach programmes etc.

(a) to (c): Yes Sir. The vision of the proposed policy is to drive economic growth and business competitiveness of the country through an integrated, seamless, efficient, reliable, green, sustainable and cost effective logistics network leveraging best in class technology, processes and skilled manpower.

(d) & (e) Though, there is no official estimation of logistics cost for India , some private institutions have estimated the logistics cost to be 13 to 14 percent of the GDP. The proposed policy aims to reduce this to 9 -10 percent of the GDP.

BENEFIT OF FTAs TO SMALL EXPORTERS

(a) to (d): The Free Trade Agreements (FTAs) signed by India provide tariff concessions thereby giving opportunities for exports of products including those related to small and medium enterprises (SMEs). Some of the SME products on which tariff concessions have been provided by trading partners such as Japan, South Korea and some ASEAN countries fall into the category of readymade garments, leather goods, processed foods and engineering products like auto components. The specific export promotion schemes for micro, small and medium enterprises (MSMEs) include those for participation in international exhibitions and fairs, training programme on packaging for exports, Market Development Assistance (MDA) Scheme for MSME exporters and National Award for quality products. The Government has also taken the following key steps to boost India's trade and competitiveness:

- i. The new Foreign Trade Policy (FTP) 2015-20 was launched on 1st April 2015. The FTP 2015-20 provides a framework for increasing exports of goods and services as well as generation of employment and increasing value addition in the country, in line with the 'Make in India', 'Digital India', 'Skills India', 'Startup India' and 'Ease of doing business' initiatives. The policy, inter alia, rationalised the earlier export promotion schemes for increasing export of goods and services.
- ii. A new logistics related division was created in the Department of Commerce to coordinate integrated development of the logistics sector. India's rank in World Bank's Logistics Performance Index moved up from 54 in 2014 to 44 in 2018.
- iii. Various measures for improving ease of doing business were taken. India's rank in World Bank 'Ease of doing business' ranking improved from 142 in 2014 to 63 in 2019 with the rank in 'trading across borders' moving up from 122 to 68.
- iv. A comprehensive "Agriculture Export Policy" was launched on 6th December, 2018 with an aim to provide an impetus to agricultural exports.
- v. A new scheme called "Trade Infrastructure for Export Scheme (TIES)" was launched with effect from 1st April 2017 to address the export infrastructure gaps in the country.
- vi. Interest Equalization Scheme on pre and post shipment rupee export credit was introduced from 01.04.2015 providing interest equalisation at 3% for labour intensive / MSME sectors. The rate was increased to 5% for MSME sectors with effect from 02.11.2018 and merchant exporters were covered under the scheme with effect from 02.01.2019.
- vii. A new scheme called "Transport and Marketing Assistance" (TMA) has been launched for mitigating disadvantage of higher cost of transportation for export of specified agriculture products.

RESTRICTIONS ON FARM EXPORT

(a) Yes, sir. The decision to impose export restrictions on a farm product is based on a number of factors such as domestic supply and price position, concerns of food security, need to balance between remunerative prices to the growers and availability of agricultural products to common man at affordable prices, requirements of importing countries, etc. Among the major agricultural products, restrictions exist on export of mustard oil, which is allowed to be exported only in branded consumer packs of up to 5 Kg subject to a Minimum Export Price of USD 900 per MT. The export of onions has been prohibited with effect from 29th September 2019. In addition, the export of a number of seed varieties is restricted.

(b) The Government is in favour of a stable export policy for the farm products. The Agriculture Export Policy provides that export restrictions will be imposed only on the commodities, which are essential for food security, under extreme price situation based on decision of a high-level committee. Consequently, mandate of the Committee of Secretaries on 'Essential commodities' has been expanded to provide recommendation on export restrictions on a few commodities, which are essential for food security, under extreme price situation only.
