

Minutes of 2nd MEETING (FY 2011-12) OF THE EMPOWERED COMMITTEE ON ASIDE SCHEME (EC) UNDER CHAIRMANSHIP OF COMMERCE SECRETARY ON 14.10.2011 (FRIDAY) AT 04:30 PM IN ROOM NO. 141, UDYOG BHAVAN, NEW DELHI

EC met with Dr Rahul Khullar, Secretary to the Govt. of India, Department of Commerce (DoC) in chair, on 14.10.2011 in Room No. 141, Udyog Bhawan. A list of participants is at Annex-1.

2. Shri Ravi Capoor, Joint Secretary welcomed participants and informed the EC that for the year 2011-12, Rs 850.96 crore have been allocated under ASIDE Scheme. As per ASIDE Scheme Guidelines, 80% of these funds i.e. Rs 680.00 crore have been earmarked for State Component and balance 20% of the total allocation i.e. Rs 170.96 crore are to be allocated under the Central Component of ASIDE. Of these funds, an amount of Rs 29.52 crore has already been utilized so far, leaving a balance of Rs 141.44 crore under this head. A total of 9 deferred projects, 36 new projects, 11 ongoing and 2 projects for ex-post facto approval were submitted for consideration of EC.

2.1 Commerce Secretary emphasized the following policy decisions as under:-

2.1.1 Land free from all encumbrances is prerequisite for consideration of projects for assistance under ASIDE.

2.1.2 Agency must approach State for infrastructure projects and activities which are primary responsibility of the State or for projects falling in their exclusive domain and only thereafter, agencies (if need be) need to approach EC on ASIDE for assistance under Central component of ASIDE.

2.1.3 As of now, Empowered Committee would consider project(s) worth Rs 20-25 Cr as total cost of project wherein assistance for such a project under ASIDE may be considered upto Rs 10-15 Cr in installments in a period of two years. Empowered Committee on ASIDE will consider such big critical infrastructure projects subject to budgetary constraint of ASIDE.

2.1.4 Agency like Port Trusts etc must priorities their projects and accordingly come with one or two project(s) for assistance before EC on ASIDE which should not be too big. Agency must show, among others, the necessity of the project and reason for consideration of such project on cost sharing basis.

2.1.5 Agencies must complete projects sanctioned within stipulated timeline / maximum gestation period of two years. Any deviation on this account would be viewed seriously.

2.1.6 The next meeting of Empowered Committee on ASIDE will be held on 28th November, 2011 at 3:00 PM.

3.6 Project of Post facto approval/information/Decision of EC on ASIDE:

3.6.1 Kandla SEZ: Construction of SDF Building(Ground plus) 6000 Sqm

Brief of the project: The instant proposal was approved by EC on ASIDE in 2009-10 with total (100%) assistance of Rs 1393.37 lakhs against the total project cost of Rs 1393.37 lakhs. So far Rs1161.14 lakhs has been released under central component of ASIDE to KASEZ. KASEZ has now submitted that the balance amount of Rs 232.23 lakhs have been paid by KASEZ Authority and therefore no fund is required. In view of above, the instant project stands to be supported by the total assistance of Rs 1161.14 lakhs from ASIDE (Central) and Rs232.23 lakhs from KASEZ Authority against the total project cost of Rs 1393.37 lakhs.

The above concurred by the Empowered Committee on ASIDE.

3.6.2 Kandla SEZ: Green SEZ and Solar Energy System(Phase-1)

Brief of the project: The project—“Green SEZ and Solar Energy System(Phase-1)” of Kandla SEZ(KASEZ) was placed before the 1st meeting(FY 2011-12) of the Empowered Committee(EC) on ASIDE held on 26.7.2011 for its consideration and the EC decided for assistance of Rs 700.00 lakhs under ASIDE with MNRE contribution of 300.00 and directed to release 700.00 subject to cost verification. KASEZ later on submitted that the actual total project cost is Rs 9.9199 Cr against the earlier submission of Rs 10.00 Cr and therefore the project may be considered as under:

The sanction for release of Rs 7.00 Cr has been issued vide DoC sanction order no. 13/6/2007-SC dt 5.10.2011.
