Minutes of the meeting of the Inter Ministerial Committee (IMC) for consideration of proposals for setting up of ICDs/CFSS/AFSS held under the Chairmanship of Shri A.K. Bhalla, Additional Secretary, Department of Commerce on 02-09-2015.

Inter-Ministerial Committee (IMC) held its meeting on 02-09-2015 in Udyog Bhavan, New Delhi under the Chairmanship of Shri A.K. Bhalla, Additional Secretary, Department of Commerce, for consideration of proposals for setting up of Inland Container Depots(ICDs)/Container Freight Stations(CFSS)/Air Freight Stations (AFSS) in India. Following officials participated in the meeting:-

2. Initiating the discussions, Chairman of IMC sought a round of introduction of the IMC members / representatives who attended the meeting. At the outset, after brief discussion, it was decided that in cases where IMC agrees to 'in principle' pending formal comments of a member of IMC from concerned Ministry can be subsequently processed and cleared on file on receipt of the formal comments without waiting for the next IMC meeting subject to the condition that the same should be brought before the next IMC for ratification. Chairman opined that this is imperative in avoiding unnecessary procedural delays in implementing the projects by the developer.

2.1 It was agreed by all the members of IMC that the submission of cases to IMC would be enabled online and perhaps even time-lined. Deputy Secretary (Infra) will draw up a time line and be the nodal officer for its time bound implementation.

2.2 Chairman also observed that there are number of proposals seeking extension of Lol for want of CBEC / Customs clearance on various interconnected issues such as issue of Customs notification under Section 7 (aa), Sec.8 and Sec 45, of the Customs Act posting of Customs staff on cost recovery basis and EDI connectivity. Chairman also requested Department of Revenue / CBEC to examine issue of Customs Notifications under Section 7(aa), 8 and 45 Customs Act to expedite the same so that the ICDs / CFSS / AFSS could start functioning at the earliest, which would avoid delays as a lot of investment has been made by the developers. A reference at the level of Commerce Secretary to be made to Revenue Secretary to sensitize the D/o Revenue about the delays caused in implementing infrastructure projects due to the customs infrastructure and manpower related issues.

2.3 Chairman observed that though Department of Revenue does extensive examination, including field level inspection and background checks of the developer(s), a mechanism needs to be put in place by them to improve the channel of communication between the field level Customs officers and CBEC to augment the pace of furnishing comments on these projects.

2.4 Chairman also directed that cases relating to routine extension of Letter of Intent, which are clear from all other angles, should be processed on file and later ratified by IMC. Chairman opined that this will avoid unnecessary delay in implementing the projects by the developer.

2.5 Issues pertaining to amendments to guidelines / check list for dealing with proposals for setting up of ICDs / CFSs / AFSs in India were discussed. IMC, Chairman observed that necessary amendments to the guidelines / check list which are required should be done in a comprehensive manner after taking comments of all the IMC members and the matter would be dealt in the file for approval of competent authority.

2.6 The issue of approvals / NoCs from line Ministries have been discussed as under :-

- (i) In the NOCs furnished by the Line Ministries presently the approving authority in the department is not mentioned. This needs to be mentioned while issuing NoC.

It is, therefore, requested that the file be routed through the respective IMC members of the Line Ministry and NOC should be issued after extensive and exhaustive back ground checks which are to be undertaken before forwarding the NOC to Department of Commerce by various line Ministries who are Members of IMC. While communicating NOC, the level of approval should be invariably indicated in the NOC.

- (ii) if any line Ministry wants clarification from another line Ministry, the same should be sought directly from that line Ministry. The comments / concurrence of the IMC members should be unambiguously clear.
