Minutes of the Empowered Committee of MAI held on 11.09.2012 in Room No. 141 under the Chairmanship of Shri S. R. Rao, Commerce Secretary.

List of participants is annexed.

At the outset Chairman extended a warm welcome to all participants and observed that increasing trade imbalance should be a cause of concern. Innovative efforts for increasing exports to new markets like Africa, LAC, ASEAN, China, South Asia are required to be taken in a concentrated manner by Export Promotion Councils. Participation in exhibitions / events in US and Europe should be kept to a minimum level. Henceforth, the financial support under MAI scheme would be allocated keeping in view the contribution of product groups in the overall exports form India. In whichever product group there is a decrease in exports, the MAI support would be reviewed in the later part of the year. It is therefore in the interest of all sectors to maintain the momentum in exports and the same should be reflected in the export data.
