Major Achievements of the Department of Commerce during April, 2020

I. **Trade**

- The merchandise trade deficit for March 2020 was estimated at USD 9.76 billion as against the deficit of USD11.00 billion in March 2019.

II. **Export Promotion Councils**

- M/s Simens Gamesa, a member company of Project Export Promotion Council of India (PEPC) has secured a 20-year contract to provide full-scope O&M services for a 135-MW Senvion wind farm in Victoria, Australia. M/s Simens Gamesa also secured an order to supply turbines for the 342 MW Kaskasi offshore wind power plant in the German North Sea in addition to another 312 MW Turbine Order in Brazil.
- M/s Larsen & Toubro Ltd., a member company of Project Export Promotion Council of India (PEPC) has been awarded a prestigious order in Kuwait to upgrade substations and related power facilities in KNPC's Mina Al Ahmadi oil refinery. The revamped network of distribution substations with latest technology will enhance reliability of power supply and facilitate expansion.
- M/s Larsen & Toubro Ltd. has also won a 400 kV Grid Station order in Oman which will be a crucial element in the Sultanate's major transmission initiative to interconnect the grids in the south and north with the PDO area and an order to Design, Supply, Construct & Commission a 220 kV Gas Insulated Substation in Egypt.
- PEPC circulated information about sixty-four (64) upcoming projects to its members in April, 2020.
- Gems & Jewellery Export Promotion Council (GJEPC) organized 21 Webinars during the month of April, 2020 with participants from various industry stakeholders on various topics such as Way forward for the industry post Covid-19, MSME Webinar series on various topics, digital marketing strategy amidst a global crisis, International market scenario & way forward post lockdown, Boosting export through effective marketing strategies after COVID-19 etc.
- DGFT, based on the recommendations of Ministry of External Affairs granted exemptions during the month of April, 2020 to export Hydroxychloroquine to

68 countries and Paracetamol to 23 countries from whom requests have been received for procuring the same.

IV. **Plantation**

- The Rubber Board convinced the State Governments to resume rubber tapping and operations of rubber processing units to ensure uninterrupted supply of latex and also continued cultural operations in rubber plantation sector including rain-guarding, considering increased demand for gloves and other allied products during COVID-19.

V. **APEDA**

- In view of the higher freight charges charged by the Airlines due to lockdown, APEDA held meetings on daily basis through VC with Ministry of Civil Aviation, AAICLAS, Air India, VAFA and Freight Forwarders for facilitating the exporters in connecting to Airlines as well as for freight negotiation with Air India allowing export of fresh horticulture produce to overseas destinations. This immediate intervention helped in air shipment of agricultural produce by air to major destinations, i.e, London, Frankfurt, Sharjah from 13th April, 2020 onwards through Air India from Mumbai, Kochi, Kolkata airports. Further, another consignment of 2.7MT of fresh vegetables was sent on 23rd April, 2020 from Varanasi, Uttar Pradesh to London through British Airways.
